## SIGN CONTRACT

### THE FIRST PARTY AND SECOND PARTY MUTUALLY AGREE AS FOLLOWS:

The SECOND PARTY agrees to purchase one (1) 4-ft x 8-ft advertisement sign to be displayed during the regular baseball and softball season(s) on the outfield fence of one of the four baseball fields at Hugh MacRae Park or on one of the three softball fields at the Hugh MacRae Athletic Complex. The SECOND PARTY, further agrees to pay for the above advertisement sign on the selected plan from the following:

- \_\_\_\_\_ \$300.00 / yr. A one year commitment only
- \_\_\_\_\_ \$200.00 / yr Commitment for three (3) years @ \$200.00 annually.
- \_\_\_\_\_ \$500.00 Commitment for three (3) years paid in advance

Verbiage and artwork for the aforementioned advertising sign shall be mutually agreed upon in advance. Any subsequent changes or modifications to the verbiage and/or artwork during the life of this contract shall be at the expense of the SECOND PARTY, unless otherwise agreed to in writing. After the SECOND PARTY approves initial artwork, the FIRST PARTY will be responsible for ordering, producing, paying, installation, storage, maintenance and repairs for the sign for the duration of the contract period.

The FIRST PARTY will bill the SECOND PARTY prior to the opening of the baseball/softball season, in the appropriate year for any outstanding balance due.
